Please read carefully, as entries that do not conform to these rules will be returned unjudged to the owner.

Final Deadlines for AV Presentation: must be Carrier dated no later than **April 29**, 2008

Remember to enclose the proper fees. DVD will not be returned unless accompanied with a print salon entry.

This competition is separate from the usual print entry, and the Wedding Album Category. You may enter four prints plus the AV Presentation, and/or the Wedding Album. The fee is \$ 50.00 (including GST). Please enclose with your DVD in a jewel case. Cheques should be made out to "PPABC" or enclose your authorization for payment by credit card. The entry should be submitted as a DVD in a jewel case with identifying information on the outside of the cover (case) only. No identifying information of the studio or maker is to be in the DVD show itself.

Your AV Presentation is to be no more than 5 minutes in length maximum. Entries will be judged on story telling, creativity, craftsmanship, slide transitions, relevance to the theme, emotional impact (if applicable) and choice of music. Entry should be one theme, one subject matter. **NB.** An accepted entry in this class does not help qualify you for Photographer of the Year. It is not considered 'another category' for these purposes. Merits granted will be the same as for an accepted PPABC print.
